### WAIVER & AGREEMENT

#### Liability Release (A)

1. We agree to volunteer our time and talents to assist the A New Beginning Animal Rescue (ANBAR) in carrying out its mission.
2. We understand that we will not receive any monetary compensation and that we are not eligible for any benefits offered to ANBAR staff/volunteers.
3. We understand that while on duty and performing functions authorized by ANBAR, we are not covered for accident insurance and liability insurance. We accept responsibility for the individual's or group's private insurance.
4. We understand that with proper notification (24 hours) either our group or ANBAR may cancel this agreement at any time.
5. We agree to:
  - 5.1. Complete the duties that we agree and are assigned to do to the best of our ability.
  - 5.2. Arrive on time and notify staff when we are unable to work the shift or hours we had planned.
  - 5.3. Be courteous and respectful to the public, volunteers, and staff.
  - 5.4. Abide by the laws of New York State and ANBAR policies, rules and regulations.
6. ANBAR agrees to:
  - 6.1. Provide necessary training to do our assignments.
  - 6.2. Provide a safe working environment Confidentiality Statement
